Wholesale items include Beary Sweet Designs Acrylic Tear Bear Patterns, Beary Creative Tear Bear Tool, Fluffing Brushes, and booklets. Although we do **NOT** offer our mulberry paper at wholesale prices; we do offer a generous discount to our wholesale clients. Mulberry Paper **MUST BE** purchased in 5 sheet packs in order to take advantage of our reduced pricing. We do not issue refunds or discounts if you purchase single sheets.

- Your business **MUST BE** an independent retail *brick-n-mortar scrapbook supply or craft supply store located in the USA*. Sorry, we are not selling wholesale outside of the United States at this time.
- **Internet sales of our product line ARE NOT permitted other than through our website, www.thebearyscrap.com. ** Selling any of our products (including Mulberry Paper) in an internet based setting is strictly prohibited and will result in immediate closure and termination of your account.**
- When submitting your application, please include a current copy of your company's resale certificate / sales tax license. Documents may be emailed to us at info@thebearyscrap.com. We must receive these documents in order to activate your account and prior to placing your first order. Please allow us 5-7 business days to process your request.
- The **minimum opening order is \$75.00. There is no minimum for re-orders** once your account has been established.
- Patterns are cut to order. Please allow **1-2 weeks** to complete your order.
- Orders over \$100.00 will receive free shipping. Orders are shipped either United States Postal Service or UPS depending on order size and is at our discretion.
- All order must be paid for in full by credit or debit card. PayPal is also accepted. Orders may be place on our website under "Wholesale Products" category. Please make sure all information is filled out completely when placing your order. We do not retain credit card information, therefore you will need to enter your payment information for each order you make. Orders must be placed online for inventory control purposes.
- We do not accept back orders. If inventory is low on a specific mulberry paper color you need more of, please contact us and we will be happy to special order the item(s) for you through our manufacturer. A 50% deposit is required for special orders. Manufacturing may take up to 2 weeks to complete.
- Our instruction booklets and patterns are protected under copyright. Please familiarize yourself with our Angel Policy and Terms & Conditions concerning the use of our products, patterns and designs. This information is available on our website at www.thebearyscrap.com. Copying for redistribution is not permitted under any circumstances and is punishable under federal law.
- Retailers are permitted to put together Pattern Kits to sell in their stores. Kits may not include pre-torn/cut pieces from our patterns to be assembled by customers.
